LES PASSEURS

This group, consisting of people actively engaged in teaching Peter's work, having complete a teacher-training with him, was put in place after a decision taken at the AGM in 2021.

Lead voluntarily by Colette Hersnack and Sylvie Palot, its aim is to get to the essence of the concepts of Peter's teaching by making them available to all.

Pierre Casel, Sacha Daemen, Kristina t'Felt, Carine Tomas and Robin Wilmoth met for 3 days in Marcorignan in January 2022 and two other dates have been earmarked in September 2022 and March 2023.

These fruitful meetings have enabled the group to delve into ideas dear to Peter (repoussé, support, energy, role of the head), to revisit ideas from the YS (the Other in me, the yama-s), to analyse practices and explore certain themes such as: the essence of twists, rhythm in prānāyāma etc.

« The Living Breath »

2,000 paper copies were printed, and the book is also available in an electronic version via Amazon and in the bookshop chain FNAC.

Since publication, 478 books have been sold, of which 23 were in the electronic version.

Because of the pandemic and the cancellation of many workshops and retreats, more than half of the books are still in storage and the question is raised as to how best to promote this work.

Organisation of the summer retreat at la Falaise Verte

The theme of 'Looking' was chosen by the committee for the August retreat 2022.

The committee members took care of publicity and registration, which was made easier by the new functionalities on the website.

The retreat was fully booked with a waiting list, but for comfort's sake we limited the numbers of students to 30.
